

(14) EC Type Examination Certificate EPS 10 ATEX 1 268 U

(15) Description of component:

The junction boxes are used for connecting and branching of incoming and outgoing cables and wires. Cover and base of cases are fitted with captive screws made of stainless steel. The IP65 degree of protection is established by a tongue and groove seal system with sealed thread. The boxes can be used in Zone 1/2 and 21/22 according to the stated maximum surface temperature.

Type identification:



Intermediate sizes between P1 and P15h are allowed.

(17) Special conditions for safe use:

For dust applications the enclosure P1 shall only be used in locations with a low risk of mechanical damage.

The ambient temperature range is from -60°C to +100°C (silicone gasket) resp. -55°C to +80°C (NBR gasket).
